1. Governing Law

This Bid Form and any contract resulting from acceptance shall be governed by and construed in accordance with the laws of Canada and the applicable provincial laws.

2. Bid Acceptance

The Owner reserves the right to accept or reject any bid, to waive irregularities or informalities, and to accept the bid that is deemed most advantageous.

3. Confidentiality

Bidder shall keep confidential all information received in connection with this bid and shall not disclose such information without prior written consent.

4. Conflict of Interest

Bidder represents that no conflict of interest exists or is likely to arise in the submission or performance of this

bid.

5. Indemnity

Bidder agrees to indemnify and hold harmless the Owner from any claims, damages, or losses arising out of the preparation or submission of this bid.

6. Compliance with Laws

Bidder shall comply with all applicable federal, provincial, and municipal laws, regulations, and codes.

7. Intellectual Property

All intellectual property rights in the bid documents and related materials remain the property of the Owner.

8. No Collusion

Bidder certifies that the bid is submitted without any collusion, fraud, or other anti-competitive practices.
