Clause 1 – Order Confirmation and Acceptance

This Order Form, once signed by the Customer and accepted by the Baker, constitutes a binding contract for the purchase of the cake described herein. The Baker reserves the right to reject any order if it cannot be fulfilled as requested.

Clause 2 – Customization and Design

The Customer acknowledges that all design elements and specifications are subject to the Baker's professional discretion and available materials. Any images or descriptions provided are for illustrative purposes only.

Clause 3 – Allergies and Dietary Restrictions

The Customer must notify the Baker of any allergies, dietary restrictions, or special ingredient requests. The Baker will take reasonable steps to accommodate such requests but does not guarantee allergen-free products.

Clause 4 – Payment Terms

A deposit, if specified, is required to secure the order. The balance is payable upon pickup or delivery. Failure to pay may result in cancellation of the order without refund of the deposit.

Clause 5 – Cancellation and Changes

Orders may be cancelled or modified only with the Baker's prior written consent. Deposit refunds, if any, will be at the Baker's sole discretion depending on timing and incurred costs.

Clause 6 – Pickup and Delivery

The Customer is responsible for timely pickup or acceptance of delivery. The Baker is not liable for damage or loss occurring after the cake has left the Baker's possession.

Clause 7 – Liability

To the extent permitted by law, the Baker's liability for any claims arising from this contract shall not exceed the Total Price paid by the Customer.

Clause 8 – Governing Law and Dispute Resolution

This Agreement shall be governed by the laws of the Province of Ontario, Canada. Any disputes arising shall be resolved through mediation or arbitration before pursuing litigation.

Clause 9 – Entire Agreement

This Order Form constitutes the entire agreement between the parties regarding the cake order and supersedes any prior oral or written communications.

Clause 10 – Signatures

The Customer and the Baker agree to the terms set forth herein by signing below, acknowledging full understanding and acceptance of this contract.
