Services to be Provided:

Caterer agrees to provide food and beverage catering services for the Event, including setup, service, and cleanup, in accordance with the specifications mutually agreed upon by the Parties. Services include menu planning, food preparation, serving staff, and provision of necessary equipment and utensils.

Menu and Dietary Requirements:

The Caterer will provide the agreed menu as outlined in the attached Schedule A. Client shall inform Caterer of any dietary restrictions, allergies, or special requirements at least seven (7) days prior to the Event. Caterer shall make reasonable efforts to accommodate such requirements.

Payment Terms:

The total fee for the Services shall be as specified in Schedule B. Payment shall be made as follows: a deposit of ____% upon execution of this Agreement and the balance no later than five (5) business days before the Event date. All payments are non-refundable except as otherwise expressly provided herein.

Cancellation Policy:

Client may cancel the Services by providing written notice to Caterer. Cancellation more than fourteen (14) days prior to the Event shall result in forfeiture of the deposit. Cancellation within fourteen (14) days prior to the Event shall require payment of the full fee.

Liability and Indemnification:

Caterer shall maintain all necessary licenses and insurance required by law. Caterer shall not be liable for any loss,

damage, or injury arising from the Services except to the extent caused by Caterer's gross negligence or willful misconduct. Client agrees to indemnify, defend, and hold harmless Caterer from and against any claims, damages, or expenses arising out of Client's negligence or breach of this Agreement.

Compliance with Laws:

Both Parties agree to comply with all applicable federal, provincial, and municipal laws, regulations, and bylaws, including but not limited to food safety, health, and employment standards in the Province of Canada where the Services are provided.

Force Majeure:

Neither Party shall be liable for failure or delay in performance due to circumstances beyond its reasonable control, including but not limited to acts of God, war, terrorism, strikes, government restrictions, epidemics, or natural disasters. The affected Party shall notify the other promptly and use reasonable efforts to resume performance.

Termination:

Either Party may terminate this Agreement upon material breach by the other Party, provided that the breaching Party fails to cure such breach within seven (7) days after receipt of written notice. Termination shall be without prejudice to any rights or remedies available at law or in equity.

Confidentiality:

The Parties agree to keep confidential all proprietary or non-public information disclosed in connection with this Agreement and not to disclose such information to any third party except as required by law or with the prior written consent of the other Party.

Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of the Province of Canada applicable to contracts entered into and wholly performed therein, without regard to conflict of law principles. The Parties consent to the exclusive jurisdiction and venue of the courts located in the Province.

Entire Agreement:

This Agreement, including any attached Schedules, constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior discussions, negotiations, and understandings. Any amendment or modification must be in writing and signed by both Parties.

Severability:

If any provision of this Agreement is held to be invalid or unenforceable, such provision shall be severed and the remainder of this Agreement shall remain in full force and effect.

Notices:

All notices under this Agreement shall be in writing and delivered personally, by registered mail, courier, or electronic mail with confirmation of receipt to the addresses set forth above or such other addresses as may be designated in writing.
