### Clause 1 – Membership Eligibility and Acceptance

Applicant represents that all information provided is truthful and complete. Membership acceptance is at the sole discretion of the Organization. The Organization reserves the right to accept or reject any application without cause or explanation.

### Clause 2 – Member Obligations

Members agree to abide by all bylaws, rules, policies, and regulations established by the Organization, including any amendments duly adopted. Members shall conduct themselves in a manner respectful to other members, staff, and property.

### Clause 3 – Fees, Dues, and Payments

Membership fees and dues are non-refundable unless otherwise specified. Members shall pay all fees in full by the specified deadlines. Failure to pay may result in suspension or termination of membership.

### Clause 4 – Term and Renewal

Membership term shall be as indicated in the Membership Details section. Renewal is subject to approval by the Organization and payment of applicable fees.

### Clause 5 – Termination and Suspension

The Organization may suspend or terminate membership for cause, including but not limited to violation of rules, illegal activities, or non-payment of fees. Members shall have the right to appeal decisions according to the Organization's procedures.

**Clause 6 – Liability Waiver and Release**

Members acknowledge and accept all risks associated with participation in activities organized or sponsored by the Organization. Members release the Organization, its officers, directors, employees, and agents from any liability for injury, loss, or damage sustained during membership activities, except to the extent caused by gross negligence or willful misconduct.

**Clause 7 – Privacy and Use of Personal Information**

The Organization collects and uses personal information solely for membership administration, communication, and legal compliance in accordance with applicable Canadian privacy laws. Members consent to the collection, use, and disclosure of such information as described.

**Clause 8 – Governing Law and Jurisdiction**

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein. The parties submit to the exclusive jurisdiction of the courts located in Ontario for any disputes arising out of or relating to this Agreement.

**Clause 9 – Entire Agreement**

This Agreement constitutes the entire understanding between the parties with respect to membership and supersedes all prior agreements and understandings. No modifications shall be effective unless in writing and signed by both parties.

**Clause 10 – Severability**

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect to the extent permitted by law.
