Scope of Work:

Painter shall perform all painting services as specified in the attached Schedule(s), including surface preparation, application of paint or coatings, and clean-up, in a professional and workmanlike manner, complying with all applicable laws and regulations in Canada.

Materials and Equipment:

Painter shall supply all materials, labor, tools, equipment, and supervision necessary to complete the work, unless otherwise agreed in writing. All materials shall be new and of good quality.

Start and Completion of Work:

Painter shall commence work promptly upon notice to proceed and shall complete all work within a reasonable time frame, absent delays caused by unforeseen circumstances beyond Painter's control. Any changes to schedule must be agreed in writing.

Warranty:

Painter warrants that all work performed shall be free from defects in workmanship and materials for a period of one year from completion. This warranty does not cover damage due to misuse, neglect, or normal wear and tear.

Compliance with Laws and Safety:

Painter agrees to comply with all applicable federal, provincial, and municipal laws, regulations, and codes, including health and safety requirements. Painter shall maintain necessary permits and insurance coverage.

Indemnification:

Painter shall indemnify and hold Client harmless from and against any claims, damages, losses, or expenses arising out of Painter's performance of the work, except to the extent caused by Client's negligence or willful misconduct.

Termination:

Either party may terminate this Agreement upon written notice if the other party materially breaches any term and fails to cure within a reasonable time. Upon termination, Client shall pay Painter for all work performed to date.

Dispute Resolution:

Any dispute arising out of or relating to this Agreement shall be resolved first through good faith negotiations. If unresolved, parties agree to submit to mediation in accordance with Canadian mediation rules before pursuing litigation.

Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein. The parties consent to the exclusive jurisdiction of the courts located in Ontario.

Entire Agreement and Amendments:

This Agreement, including any schedules or attachments, constitutes the entire agreement between the parties and supersedes all prior negotiations, representations, or agreements, whether written or oral. Amendments must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.
