Terms and Conditions:

1. The Tutor agrees to provide tutoring services as described above in a professional and diligent manner, commensurate with their credentials and experience. 2. The Student (or Parent/Guardian) agrees to provide accurate information to the Tutor, ensure timely attendance, and communicate any cancellations or rescheduling at least 24 hours in advance. 3. Payment for tutoring services is due as per the agreed Payment Schedule. Late payments may incur additional fees. 4. The Tutor is not responsible for any academic outcome but will endeavor to assist the Student's learning. 5. Either party may terminate this Agreement with written notice. Payment for services rendered up to termination date is non-refundable. 6. The Tutor agrees to maintain confidentiality of all Student information except as required by law. 7. This Agreement is governed by the laws of Canada and the applicable provincial legislation. 8. Any disputes arising under this Agreement shall first be addressed through mediation before pursuing further legal remedies. 9. The parties acknowledge that this Agreement constitutes the entire understanding between them and supersedes all prior negotiations, discussions, or agreements, whether oral or written. 10. Amendments or modifications to this Agreement shall be valid only if made in writing and signed by both parties. 11. The Tutor certifies that they hold all necessary qualifications and licenses to provide the stated tutoring services. 12. The Student or Parent/Guardian consents to the use of personal information solely for the purposes of providing tutoring services and complying with legal obligations. 13. The Tutor makes no guarantees regarding specific academic results or improvements. 14. The Tutor and Student (or Parent/Guardian) agree to communicate respectfully and adhere to scheduled sessions. 15. Cancellation of sessions without required notice may still incur payment obligations. 16. The Tutor shall not be liable for any indirect, incidental, or consequential damages arising from tutoring services. 17. This Agreement may be

executed in counterparts, including electronic signatures, each of which shall be deemed an original. 18. Notices under this Agreement shall be in writing and delivered by hand, mail, or electronic means with confirmation.
