COPYRIGHT AND USAGE RIGHTS:

All photographs taken by Photographer are protected by Canadian copyright law and remain the intellectual property of Photographer. Client is granted a non-exclusive, non-transferable license to use the images for personal, non-commercial purposes only.

LIMITATION OF LIABILITY:

Photographer shall not be liable for any indirect, incidental, or consequential damages arising from the services provided. In no event shall Photographer's liability exceed the total amount paid by Client under this Agreement.

INDEMNIFICATION:

Client agrees to indemnify, defend, and hold Photographer harmless from any claims, damages, or expenses arising from Client's use of the photographs or breach of this Agreement.

FORCE MAJEURE:

Neither party shall be held liable for any failure to perform due to causes beyond their reasonable control, including but not limited to acts of God, government restrictions, natural disasters, or pandemics.

GOVERNING LAW AND JURISDICTION:

This Agreement shall be governed by and construed in accordance with the laws of Canada and the applicable province. Any disputes arising hereunder shall be resolved exclusively in the courts located within the applicable province.

ENTIRE AGREEMENT:

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements and understandings, whether oral or written. Any amendments must be made in writing and signed by both parties.
