Warranty and Liability:

Supplier warrants that all goods supplied under this Order shall conform to specifications and be free from defects in material and workmanship at the time of delivery. This warranty is exclusive and in lieu of all other warranties, whether express or implied, including any implied warranties of merchantability or fitness for a particular purpose. Supplier's liability is limited to repair or replacement of defective goods or refund of the purchase price, at Supplier's discretion. Neither party shall be liable for any consequential, incidental or indirect damages arising out of or related to this Order.

Governing Law and Dispute Resolution:

This Order shall be governed by and construed in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein, without regard to its conflict of law principles. Any disputes arising under or in connection with this Order shall be resolved exclusively by the courts in the Province of Ontario. The parties hereby irrevocably consent to the jurisdiction of such courts.
